Members of the Public:** Charles Marchant, newly-elected president of the Townshend Historical Society, was welcomed and reviewed the Society's recent preservation, documentation and education endeavors. Currently, the Society is focusing on Follett stone arch bridges in Townshend and hoping to receive a small grant through the Preservation Trust that will help in making a professional assessment of conditions and provide guidance toward necessary repairs.
