ANNUAL TOWN MEETINGMINUTES MARCH 4, 2014

The legal voters of the Town of Townshend are hereby notified and WARNED to meet at the Town Hall in Townshend, Vermont, on Tuesday, March 4, 2014 at 9:00 a.m. to act on the following articles, viz:

The Assembly recited the Pledge of Allegiance and David Liebow called the meeting to order at 9:06 A.M. Several announcements were made and the location of numerous handouts and surveys was pointed out to the Assembly. The preamble was read and a brief explanation was given of the procedure that would be followed during Town Meeting.

Thanks were given to Michael Charles for his generous donation of desks, chairs, tables and other office supplies.

The moderator introduced the Select Board members.

ARTICLE I. To choose a Moderator for the ensuing year:

David Liebow opened nominations for Moderator.

Nominated: David Liebow.

There being no others, nominations were closed and the clerk was instructed to cast one ballot for David Liebow as Moderator for a term of one year. Motion seconded and passed by voice vote.

David Liebow, 1 year term as Moderator

Motion was made to suspend the rules to allow Richard Marek to speak which was passed without objection.

He spoke to several issues, took questions and left at 9:20.

Town Meeting was recessed to reconvene after the Townshend Elementary School District 2014 Annual Meeting:

The Moderator reconvened the Town Meeting at 10:49 A.M.

Mr. Liebow thanked all School Board Members and Teachers.

ARTICLE II. To approve the July 1, 2012 - June 30, 2013 Auditors' Report:

So moved by Henry Martin and seconded.

Discussion: Date taxes due were not listed in the summary of the minutes for last year.

Kris Kuch explained that previous years minutes are only a summary. The complete minutes are available at the Town Clerk's Office and online.

Henry Martin thanked Ms. Kuch for all her hard work on the preparation of Town Report.

There being no further discussion the motion passed by voice vote.

Article II passed

ARTICLE III. To see if the Town will vote to take advantage of the provisions of V.S.A. Title 24, Chapter 37, and authorize the Select Board to employ a Town Manager?

So moved by Carole Melis and seconded.

Discussion: Concerns about where the money would come from. Mr. Martin explained that if a Town Manager was Hired, the Administrative Assistant position would be eliminated.

The Town Manager would possibly take over the bookkeeping duties as well.

The Administrative Assistant/Bookkeeper earns \$33,500.00 per year. A Town Manager would require a more substantial Salary.

The possibility of hiring a Town Manager was brought before the town in 1988.

The Town Manager could possibly be a liaison between departments in hopes of avoiding conflicts.

Mr. Martin stated that the town is in dire need of help.

Suggestion was made to formulate a group of citizens to look into the position and duties. Determine how much time would be needed to efficiently do the job. Would it need to be full time or would a part time position suffice?

Motion to amend motion to read "for a period not to exceed one year and for a salary not to exceed 32,500.00" was made by Eugene Kuch and seconded.

Cliff Passino called the question on Motion to Amend.

Motion to Amend the motion failed by voice vote.

Discussion continued – A Town Manager would have more time to apply for grants, tax credits, etc.

Discussion suspended to allow Senator Peter Galbraith to speak – Objected to by Philip Moriarty – Requesting a time limit of 5 minutes.

Mr. Galbraith addressed the Assembly regarding Health Care, Taxes, Environment, Division of Townshend, etc.

Discussion on Article 3 resumed.

Possibility of soliciting towns people to volunteer their time to do things such as grant writing, trips to Montpelier, etc.

Do more research – table until next year.

Charlie Marchant called the question. Request for paper ballot.

Yes – 63

No - 75

Article III failed

Motion to recess for lunch at 12:01 p.m. until 1:00 p.m. moved and seconded.

Meeting reconvened at 1:01 P.M.

Discussion: Why? Would it be cost efficient to hire an outside firm at the time of a re-appraisal?

Cost of the last re-appraisal - \$86,000.00 +/-

Tax map updates. Listers are working with Dauchy Creamer in an attempt to get revised Tax Maps.

Warren Beattie moved to call.

There being no further discussion the motion failed by voice vote.

So moved by Carole Melis and seconded.

Discussion: Kris Kuch addressed the position of Auditor. She explained the duties and responsibilities.

This year there was a lack of full representation by all auditors. If individuals run for the position and cannot fulfill their obligation they need to resign.

Need qualified people to do the job.

The Select Board would oversee any professional auditor appointed by them.

There being no further discussion the motion failed by voice vote.

Discussion: Questioning custodial wages and repair and maintenance. Cleaning woman who cleans the Town Hall also cleans the Town Garage for less money.

Routine maintenance on building; doors, well, generator, electrical, etc.

There being no further discussion, the motion passed by voice vote.

ARTICLE X. To see if the Town will vote to raise \$ 95,000.00, by taxation, to be used toward the purchase of a new Highway Department truck?

So moved by David Dezendorf and seconded.

Discussion: Replacing truck T8 same truck as in last year's warning.

Due to increase in tax rate the SB decided to put off purchasing the truck until the next fiscal year

Would leasing vehicles be more cost productive? It is more beneficial to purchase and trade in

Jeff Russ moved to call the question.

There being no further discussion, the motion passed by voice vote.

Article X passed

ARTICLE XI.

To see if the Town will vote to appropriate \$ 1,007,455.15 for the running expenses and liabilities of maintaining the Town's roads, of which \$ 759,455.15 to be raised by taxation?

So moved by David Dezendorf and seconded.

Discussion: The highway budget includes the \$95,000.00 for the purchase of a new truck.

What does the town currently owe for equipment? \$120,570.00

There being no further discussion, the motion passed by voice vote.

Article XI passed

ARTICLE XII.

To see if the Town will authorize the Select Board to spend up to \$125,000.00 for the modernization, expansion and/or relocation of Townshend's Transfer Station and recycling facility?

So moved by Henry Martin and seconded.

Discussion: Two motions in one. Not a lot of detail. Need a conceptual design and options.

Money requested to do a conceptual design was defeated last year.

Either buy a new compactor or build a new transfer station with composting capabilities.

New transfer station would be gated to prevent non-residents from depositing their trash when transfer is not manned. If a new Transfer Station is built it would most probably be built on Taft Meadows.

Was there any research done on possibly purchasing a second hand compactor?

Motion to amend Article made by Carole Melis and seconded to modify motion article to read; "To see if the Town will authorize the Select Board to spend up to \$125,000.00 for a new compactor to remain at the same location?

Discussion continued regarding looking into a box truck and the permitting needed. Take time to develop a composting plan for the future.

Dick Jackson called the question.

Vote on Amendment – Passed

There being no further discussion the motion, as amended, as amended passed by hand vote.

Article XII, As Amended, passed

ARTICLE XIII. To see if the Town will vote to raise \$ 44,832.00, by taxation, for the running expenses and

liabilities of the Library?

So moved by Henry Martin and seconded.

Discussion: Motion to amend made by Ryan Hockertlotz to add language to authorize the Library to spend any monies brought in by grants and donations.

Amendment failed by voice vote.

There being no further discussion, main motion, as presented, passed by voice vote.

ARTICLE XIV. To see if the Town will vote to raise \$10,000.00, by taxation, to be placed in the Capital

Expenditure Fund Fire Department Reserve toward a future pumper?

So moved by Carol Melis and seconded.

Discussion: Anticipated date for replacement of pumper – 2020

There being no further discussion, the motion passed by voice vote.

ARTICLE XV. To see if the Town will vote to raise \$ 1,500.00, by taxation, for the Old Cemetery Fund?

ARTICLE XVI. To see if the Town will vote to raise \$ 14,410.00, by taxation, for the support of Social Services,

as recommended by the Screening Committee?

The committee was thanked for a job well done.

There being no further discussion, the motion passed by voice vote.

ARTICLE XVII. To see if the Town will authorize the Board of Selectmen to set a tax rate sufficient to cover all monies raised for municipal entities for the period July 1, 2014, through June 30, 2015, and to

borrow money in anticipation of taxes?

There being no discussion, the motion passed by voice vote.

ARTICLE XVIII. To see if the Town will authorize the Board of Selectmen to sell or convey properties acquired by

the Town through tax sales and to execute, acknowledge and deliver deed and other transfer documents upon such terms and conditions as the Board of Selectmen may deem to be in the

interest of the Town?

So moved by Charlie Marchant and seconded.

Discussion: What would happen if the town is given land?

There being no discussion, the motion passed by voice vote.

ARTICLE XIX. To see if the Town will authorize the Board of Selectmen to acquire, by gift or purchase, land for

municipal forest, to promote reforestation, water conservation and good forestry practices?

ARTICLE XX. To see if the Town will vote to set the first Tuesday in March 2015, as the date for the 2015

Town of Townshend Annual Meeting?

There being no further discussion, motion, as amended, passed by voice vote.
