The Grants In Aid Project is back in progress with Hunter Excavating coming the last week of July. Plumb Road between the lower culvert and 662 Plumb Road will be closed for a small period of time. Signage and notice will be posted in advance

The highway Department had \$7,000.00 in FY21 budget to purchase 8in minus ditch stone. Frisk would like to purchase the stone and bring in to the Town Pit, and use some to do West Hill, another Grants In Aid project. Mansfield motions to purchase \$7,000.00 worth of ditch stone, Wright seconds, carried by those present
